Shanghai University of Engineering Technology Implementation Rules for Course Credit Recognition and Grade Conversion for Overseas Study and Exchange Students

According to the relevant provisions of the Interim Regulations on the Management of Overseas International Exchange Students of Shanghai University of Engineering Technology (Trial) (Hu Yi Jiao [2012] No. 50), international exchange students of our university can apply for credit recognition and grade conversion for courses taken in overseas universities.

Credit recognition

The overall principle of course credit recognition is the course-based credit correspondence principle. According to the content of the courses taken in overseas universities, courses that are the same or similar to the compulsory courses of our school's majors will be converted according to the compulsory courses of our school's majors. Professional courses without corresponding courses in our school will be converted according to professional elective courses. Non-professional courses are subject to credit conversion according to public elective courses. Students who study abroad can choose the corresponding courses from all courses in their training program for credit recognition. Please refer to the table below for the specific number of credits and courses that can be converted into our school:

Exchange school course credits	The number of courses in our school can be converted
4 credits and below	1-2
4 credits or more, 10 credits or less	1-3
10 credits and above	1-4

Note:

- 1. Our school's ideological and political courses cannot be converted, and must be made up or taken after returning to school;
- 2. Language courses taken in overseas universities can only be converted into similar language courses or public elective courses in our university.
- 3. The total number of credits converted does not exceed the average number of credits in the semester's major.

2. Course selection process

The college is responsible for guiding the selection of courses for overseas study and exchange students. Before studying abroad, students should formulate course selection and course plans to be transferred according to the courses available in the corresponding semester of the exchange school, combined with the suggestions of tutors and colleges, fill in the "Exchange Student Course Selection Application Form" (Annex 1), and after the signature and approval of the department head and the



dean in charge, the Academic Affairs Office will file it. Students are not allowed to change courses or change courses without authorization, otherwise they will not be recognized. If students need to change courses due to objective reasons (supporting materials are required), students need to apply in time during the exchange and study period, and can only be implemented after the approval of the college and the filing of the Academic Affairs Office.

3. Grade conversion

After the students return to the school to register, the college will organize the completion of the "Application Form for Course Credit Recognition and Grade Conversion for Exchange Students" (Annex 3) according to the transcript provided by overseas universities, the college according to the "Application Form for Course Selection for Exchange Students" and the transcript, and according to the "Instructions for Grade Conversion between Overseas Exchange Schools and Our School" (Annex 2) in accordance with these rules. Complete the follow-up matters such as score registration.

一、目的

I. Purpose

本协议旨在建立甲、乙双方在设计领域的本科教育合作。甲方学生在环境设计或产品设计专业学习并赴乙方进行室内与设计专业的学习,共享两校的教学理念、教学资源与方法。

该本科教育合作项目旨在充分运用甲、乙双方两个独立本科学士学位的专业优势,学生在本校完成相应学业后赴乙方继续学习,最终完成双方本科学士学位教育要求。

该项目须在充分遵守各方规章制度的基础上,双方互认学分,并开展完全符合两校目前及未来管理 部门对专业认证的教育活动。

甲方学生赴乙方学习期间,需在派出学校进行注册。

The purpose of this Agreement is to establish the Academic collaborative program between NABA and SUES as follows:

NABA BA in Interior Design and SUES BA in Environmental Design where students can benefit from the perspective and approaches delivered by both SUES and NABA.



The Academic Collaborative program, which is based on two self-standing programs, the NABA BA Interior Design and the SUES BA in Environmental Design, allows students who are studying at SUES to transfer to NABA.

NABA BA in Design and SUES BA in Product Design where students can benefit from the perspective and approaches delivered by both SUES and NABA.

The Academic Collaborative program, which is based on two self-standing programs, the NABA BA Design and the SUES BA in Product Design, allows students who are studying at SUES to transfer to NABA

The Academic Collaborative programs would be possible thanks to the mutual recognition of credits between the two Parties and are subject to the full compliance to the respective accreditation requirements of both Parties by respective current and future regulatory bodies and would be valid only if and when the full respect of the regulations of each Party would be granted.

It is agreed between the Parties that during the study time at NABA, SUES will register them anyway into its official records.

SUES "BA Degree for Environmental Design" and "BA Degree for Product Design" are the first cycle degree (Bachelor's Degree) giving access to second cycle degrees (Master Degree) courses.

SUES Degree Programs has been accredited by the Chinese Ministry of Education. SUES, as a legal entity, possesses the qualification of conducting the collaboration with higher education institutions worldwide.

NABA "Diploma Accademico di Primo livello in Design" (major interior and design) is the first cycle degree (Bachelor of Arts Degree) giving access to second diagram (Bachelor of Arts Degree) **ACCADEMIA**

courses.

The programs were accredited by the Italian Ministry of Education on 08/11/2016. NABA General Regulation provides for agreements with EU and non-EU institutions.

Both Parties are responsible for complying with specific requirements to maintain the accreditation.

三、"3+1"本科合作项目描述

III. "3+1" Academic Collaborative Program Description

- 1."3+1"本科合作项目指甲方本科计划内学生在该校完成前三年的学业,符合条件者赴乙方进行最后一个学年的学习,完成乙方规定的学业后,将获得乙方学士学位证书。甲方学生在完成本校规定的本科论文答辩的基础上,经甲方考核通过,甲方颁发本科毕业证书及学士学位证书。乙方认可学生在甲方修读的学分。
- 1. The "3+1" Academic Collaborative program empowers SUES to select eligible undergraduate students who have completed three-years undergraduate study on campus to transfer to NABA for further study at NABA for one academic year. Under the "3+1" Academic Collaborative program, those students who successfully complete the final year of the NABA relevant program, subject to course mapping in NABA, shall gain the relevant NABA Bachelor Degree. SUES will award its own BA Degree and graduation certificate upon student's successful completion at SUES. The credits earned by program students during their study at SUES shall be recognized by NABA.
- 2. 进入该"3+1"**本科合作**项目的甲方学生在完成本**校前三年学**业后,赴乙方进行设计本科专业最后一年的学习,即:乙方第三学年的课程(该专业为英语授课)。甲方学生在乙方完成合作项目最后一年的学业,获得乙方规定的学分,通过乙方毕业考试委员会论文答辩后,方可被授予乙方设计学士学位。环境设计和产品设计专业的学生在 NABA **学**习期间所获得的学分将得到 SUES **的**认可。
- 2. SUES students who would choose to transfer to NABA within the Academic Collaborative program, upon SUES third-year completion, would enter the third year at NABA within BA Design (English Language track). In order to graduate and obtain the NABA Design BA Degree, Program students should have earned the required credits and should discuss their Final Thesis in front of the NABA graduation exam commission. The respective credits earned by programs students in Environmental Design and Product Design during their study at NABA shall be recognized by SUES.
- 3. 学生在完成乙方设计专业第三学年(即合作项目最后一年)课程的学习后,毕业考试结束时获得"设计学士学位"证书。

根据 05/03/2019MIUR 公告 389 条款,该专业课程评估证书符合欧洲标准规定。

3. Upon successful completion at NABA, all program students are issued the NABA Diploma Supplement.

NABA would issue the Diploma Supplement of the "Diploma Accademico di Primo Livello in Design" at the end of the graduation exam.

The Diploma Supplement issued by NABA complies with the European standards, according to the MIUR Notice 05/03/20219, protocol no 389.

For the final year study at NABA, SUES will interview students and select eligible students for the project. NABA will review the application and materials of the students and interview them. The final admission of students for the final year studies shall be decided by NABA.

Students for the project shall be registered students at SUES. The exact number of students for the project shall be decided by SUES based on students application and SUES shall negotiate with NABA in advance.

- 4. 在获得乙方同意的基础上,甲方可选派项目相关教师作为访问学者赴乙方学习与合作交流。 With prior consent of NABA, SUES can send teachers to NABA as visiting scholars for studying and exchange.
- 5. 因签证或者家庭等原因无法前往乙方学习的甲方学生,将继续在甲方完成本科最后一年的学业。 经考核通过,甲方颁发本科毕业证书及学士学位证书。

The students who cannot go to NABA due to visa or family reasons will continue their last-year study at SUES. Those who meet the graduation requirements of SUES will be granted the graduate certificate and bachelor degree issued by SUES only.

- 6. 乙方为符合毕业要求的甲方学生颁发乙方本科学士学位证书。乙方本科学位证书原件将直接寄到上海工程技术大学教务处,由甲方统一颁发给学生;

Issuing the NABA Bachelor Degree to the qualified students from SUES; students' hard copy of their NABA Bachelor Degree will be directly sent to SUES Academic Affairs Office as soon as this would be available; SUES will deliver the NABA Bachelor Degree to the respective students.

7. 协助甲方访问教师通过乙方的住宿服务中心寻找住宿;

Assisting SUES faculty in finding the accommodation through appropriate separate service, that is, NABA Housing Service;

Provided that all such background intellectual property will be treated in strictest confidence by all recipients thereto.

All foreground intellectual property being intellectual property that arises from work undertaken under the agreement, shall be owned by the party or parties who can claim a direct intellectual input to the resultant technology, design or copyright work.

X. Publicity and Promotional Material

Neither party may use the institutional name or logo of the other without prior written approval. Such approval will require the submission of a draft copy and a listing of proposed destinations of the publicity. If the proposed publicity is not in the English language, an authorised translation shall be provided.

2. 任何一方均可提及本协议的存在,但前提是须清楚描述本协议的性质和范围且不作任何有关标准、 质量或服务的误导性的主张或评论。

Either party may make reference to the existence of this agreement provided such reference clearly describes the nature and extent of the agreement and does not make misleading claims or comments regarding standards, quality or services.

十一、协议生效及有效期

XI. Validity of the Agreement

1. 本协议自签字之日起生效,有效期5年。

This agreement will be valid for a period of 5 years from the date of first signature.

- 2. 双方可在协议到期日前一年内对合作的有效性进行审查,经双方同意可将合作协议延长或续签。 The effectiveness of the collaboration will be reviewed by both Parties no later than 12 months prior to the scheduled expiry date. The collaboration may be extended or renewed by mutual agreement following the review.
- 3. 如任何一方需终止本协议,应提前 6 个月以书面形式通知对方。如果终止日期发生在合作项目的某一阶段,协议终止前对已开展的合作项目应按照既定的条款执行,按期完成。

If either party terminates this agreement, a formal written notice shall be given to the other party six months prior to the expiration date. For the consistency of the agreement, the project assigned before the termination shall be completed.

4. 如发生争议,双方将在友好协商的基础上进行解决。 In the event of any dispute, the parties shall resolve such disputes through friendly consultation.

- 4. 参与合作项目的学生将自理在乙方学习期间的所有费用,包括学费、签证费、旅费、住宿费、生活费、材料费及其他相关费用。每一学年学费将以乙方当年官方学费为准。

Under this Academic Collaborative program, students will be responsible for paying all fees of the study at NABA, including tuition fees, visa application fee, travel, accommodation, living expenses, materials fees and other expenses. For the annual tuition fee, it should be subject to the office tuition fee of each year.

5. 参加合作项目的甲方学生需向乙方缴纳学费。乙方将在官方学费的基础上向甲方学生提供 10%的 学费减免。

Under this Academic Collaborative program, SUES students who go to NABA for the final year study shall pay the tuition fee. NABA will assure the 10% reduction on such official tuition fee.

SUES will be responsible for paying, or ascertaining the funding for, accommodation, living expenses, air fares, other travel and other associated costs for any visiting scholars who elect to spend time in NABA.

Annex 4: Graduation Thesis Writing & Oral Defense for "3+1" Program

环境设计、产品设计专业本科生需按照甲、乙双方要求分别按时完成两校的毕业论文(设计),具体安排如下:

SUES students majored in Environmental Design; Product Design shall complete the graduation thesis (senior project) on time according to requirements of both home institution and host institution. The details are as follows:

甲方环境设计、产品设计专业本科生最后一年在乙方学习,需按照乙方要求完成乙方的毕业论文(设计)。 毕业论文(设计)课题需获得乙方同意后方能开展。课题获得乙方同意后,甲方学生负责向甲方告知该课题。甲方学生必须向乙方提交论文后方可从乙方毕业。

During the final year's study at NABA, SUES students majored in Environmental Design; Product Design shall complete the NABA thesis writing according to requirements of NABA. The thesis subject should be agreed with NABA. It is agreed that SUES student would take the responsibility to inform SUES about the subject that has been agreed with NABA. SUES students must submit the Thesis to NABA in order to graduate with NABA.

甲方学生可在乙方的毕业时间为当年 7 月、9 月、12 月或次年的 2 月份。如果学生因未能通过在乙方修读课程而不能于次年 2 月毕业,在甲乙双方商定后,学生可以选择重修或重考以获得相应学分,以获得乙方本科学位。乙方相关规定及重修费用在此情况下适用。

SUES students at NABA can graduate either in July or in September or in December or in February following year. If the students fail any of the NABA courses and are unable to graduate by February of the following year of study, those students, in agreement with SUES, can choose to retake the modules or exams and acquire the credits so that they can be conferred the Bachelor's degree by NABA. In that case NABA's standard policy and fees for repeating students apply.

甲方可在甲方学生赴乙方学习前,就其在乙方最后一年学习的具体课程对甲方学生进行选课指导。 It could be up to SUES to suggest the student which course within NABA third year courses should preferably be the course where the student would select his/her subject from. This indication/suggestion could be given to the student before departure.

学生于当年七月完成乙方学业后,回到甲方进行毕业论文(设计)的初审和复审及答辩。若甲方学生于当年7月未完成乙方学业,甲方同意甲方学生在本校批准的情况下在乙方继续学习直至完成乙方学业,并在甲方规定的学籍有效期内进行甲方毕业论文(设计)的初审和复审及答辩。

Upon completion of study at NABA in July, SUES students shall return to home institution for SUES graduation thesis check, review and oral defense. If SUES students do not complete the study at NABA in July, SUES agrees that students, with the approval of SUES, could stay at host institution to continue their study till completion. Nevertheless, SUES students shall go back to home institution for their thesis check, review and oral defense before their student-status expiry date regulated by SUES.

甲方学生在按甲方要求进行毕业论文(设计)时,需按照甲方教学要求与甲方导师商议毕业论文(设计)课题。该毕业论文(设计)课题获得甲方导师认可后方能开展。

SUES students shall prepare the SUES graduation thesis (senior project) according to requirements of SUES. SUES students need to, according to SUES teaching requirements, discuss thesis topic with SUES supervisors. With the approval of SUES supervisors, SUES students can start the graduation thesis (senior project).
